IT'S THE LAW (ORC 955.01)

All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag.

(The law applies regardless of whether the dog is kept inside or out.)

This is mailed as a courtesty, please disregard if you do not have dogs to register.

Instructions for purchasing Meigs County Dog Licenses:

BY MAIL

- 1-Complete this form.
- 2-Use this form to register 1-5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form.
- 3-Enclose a check or money order for the correct fees payable to: Meigs County Auditor. Please do not send cash.
- 4-Send the completed application and payment to the addess above.

Please included a self-addressed, pre-stamped envelope for the return of your tags and receipt.

IN PERSON

If you are unable to purchase your license by mail, you may purchase them in person at the Meigs County Auditor's Office.

Dogs may be registered for a 1 year or 3 year term, or permanently. Complete each line of the application for your dog(s). In particular, choose your "Term" (1 year, 3 year or Permanent—see term codes below) and fill in "Fee Paid" based on the fee structure to the right.
